2. Reason for the change

Under the Rolling Plan of the Fourth Medium-Term Business Plan announced in February 2024, UT Group will "shift to a strategy primarily keyed to the perspective of workers" with the aim of "becoming the most preferred company by dispatch workers" by FY3/2026, the final year of the plan. We recognize the provision of the dispatch workstyle as a service for workers as the labor market has become the sellers' market due to the continued labor shortages caused by the declining workingage population in Japan. We intend to build a highly convenient service. In addition, in response to changes in the business environment, we will be engaged in hiring activities and service development with a sense of speed more than ever.

Sotomura has provided strong leadership in the Group, as a director in charge of all business divisions of the Company, by utilizing his abundant business experience in the areas of HR affairs, HR development, and sales, as well as his knowledge of overall management. In promoting the







Rolling Plan, the management structure of two representative directors, with Wakayama as Chairman and Representative Director and Sotomura as President and Representative Director, will accelerate decision-making and strengthen business execution functions.

Sotomura will lead the business and be in charge of achieving the Rolling Plan by improving the quality of the "dispatch services" through the establishment of service base and business foundation. He will also be engaged in strengthening the organizational capability. Wakayama will play a key role in formulating the next medium-term business plan and management policies to realize UT Group's long-term management vision for FY3/2030.

As a leading company in manufacturing dispatch, we will work together to create a new type of worker dispatch business for the manufacturing industry, ultimately aiming to realize our Purpose, "We at UT Group aim to realize a society in which all people who are willing to work are equally given opportunities for skill development and career formation, and are treated fairly."
